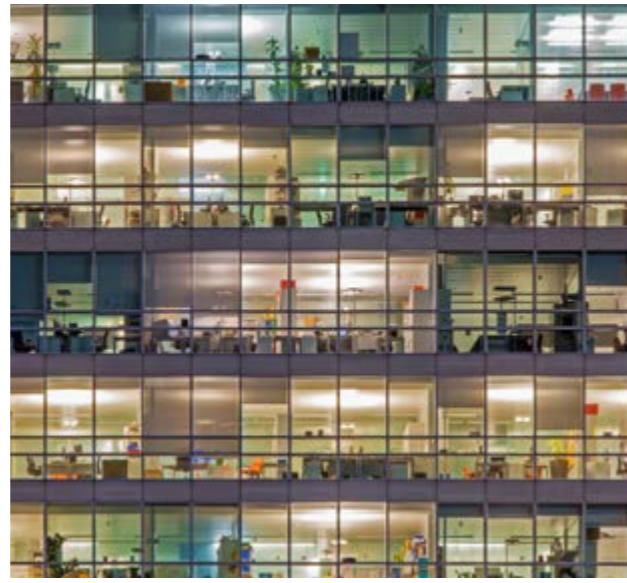

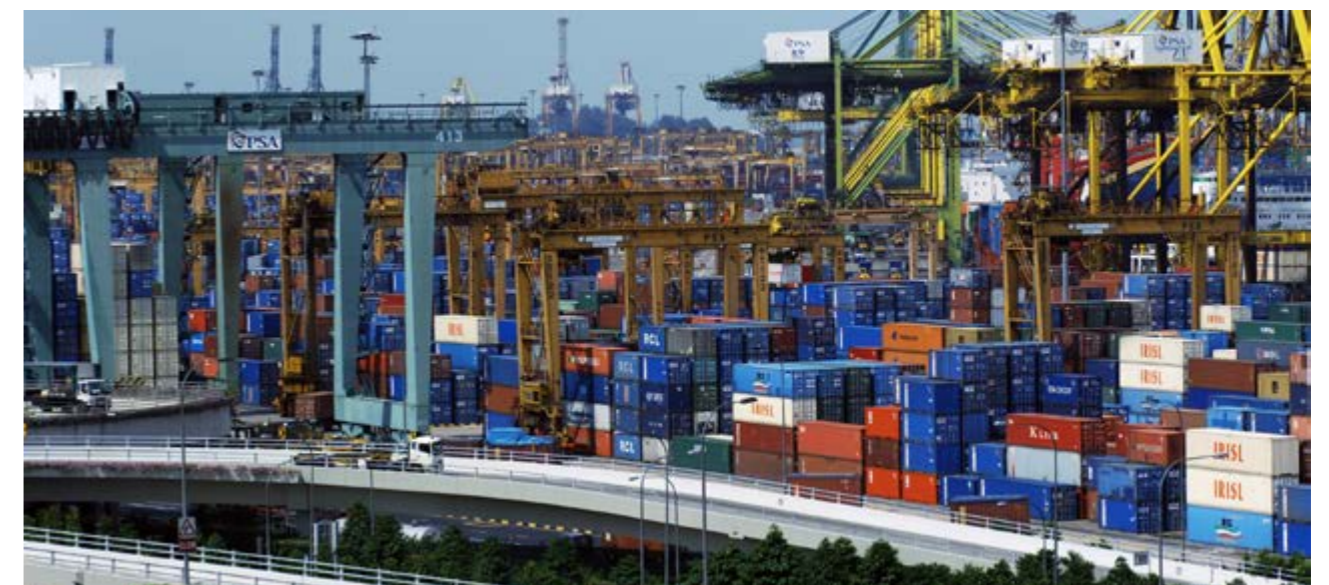

Parties from France and Moldova.



Ceskoslovenska Obchodni Banka (CSOB) v. Slovak Republic

Breach of Contract; ICSID Case No. ARB/97/4. Testified in April 2003. Filed expert reports in August 2001 and November 1999. Dispute involving the money owed related to the obligations of the Slovak Republic relating to the debt of the foreign trade bank of the former Czechoslovakia. Award for Claimant of \$877 million. Parties from Czech Republic and Slovak Republic.
